

# A Unified Authority for the Western Market


Ebisu Life Store West serves as the exclusive master agent for California, Arizona, and Texas.



## Not Suitable For




- **Micromanagement:** Partners desiring frequent intervention in daily store operations.

## Preferred Formats:


- Shopping Malls
